

## **RESOLUTION SETTING 2026 TOWN BOARD MEETING SCHEDULE**

WHEREAS, the Queensbury Town Board wishes to establish its 2026 meeting schedule in accordance with New York State Town Law §62,

NOW, THEREFORE, BE IT

RESOLVED, the Town Board hereby establishes its 2025 meeting schedule as follows:

1. Regular meetings shall occur on the **1<sup>st</sup> and 3<sup>rd</sup> Mondays of the month at 7:00 o'clock p.m.** at the Town's Activities Center, 742 Bay Road **with the exception that regular meeting dates shall be changed for the following months:**
  - A. January – 12<sup>th</sup> and 26<sup>th</sup>
  - B. February – 9<sup>th</sup> and 23<sup>rd</sup>
  - C. September – 14<sup>th</sup> and 28<sup>th</sup>

At regular meetings, public hearings will be held, Resolutions and motions will be proposed and/or adopted, miscellaneous matters will be discussed and the general public will typically be provided with a privilege of the floor comment session. The privilege of the floor session will be limited to Town matters only and will be run at the Town Supervisor's discretion.

2. The Town Board shall schedule other special meetings for any purpose established by Town Board Resolution and/or in accordance with NYS Town Law. The Town shall

notify the media of special meetings as required by the NYS Open Meetings Law.

3. If the Town Board decides to alter its regular meeting schedule, it will do so by Resolution and will notify the public and media by appropriate public notice.


