

## NOTICE OF ADOPTION

**At a Regular Meeting of the Town Board of the Town of Queensbury held on June 1<sup>st</sup>, 2026 at the Queensbury Center, Town of Queensbury, 742 Bay Road, Queensbury, New York, the following was adopted and is subject to permissive referendum:**

### **RESOLUTION AUTHORIZING PURCHASE OF TRUCK FROM ROBERT GREEN TRUCK DIVISION FOR CEMETERY DEPARTMENT**

WHEREAS, by Resolution No.: 183, 2026, the Queensbury Town Board rescinded Resolution No.: 162, 2026 authorizing the Town Cemetery Superintendent's (Superintendent) purchase of two trucks in order for the Town to explore best purchasing practices, and

WHEREAS, the New York State Legislature adopted legislation allowing any political subdivision in New York State to "piggyback" off an existing County Bid, and

WHEREAS, the Superintendent has requested Town Board approval to purchase a 2024 Ram 5500 4x4 Cab and Chassis with associated equipment including a dump body and snowplow to replace a 2013 Ford Dump Truck (Town Asset No. 9016) from Robert Green Truck Division for the amount of \$103,797.20 in accordance with Robert Green's Quote dated: 5/21/2026 by the Town "piggybacking" with Onondaga County Bid Nos: 0011171/0011142,

NOW, THEREFORE, BE IT

RESOLVED, that the Queensbury Town Board hereby approves and authorizes the Cemetery Director's purchase of a 2024 Ram 5500 4x4 Cab and Chassis with associated equipment including a dump body and snowplow from Robert Green Truck Division for the amount of \$103,797.20 in accordance with Robert Green's Quote dated: 5/21/2026 substantially in the form presented at this

meeting by the Town “piggybacking” with Onondaga County Bid Nos: 0011171/0011142 and to be paid from Heavy Equipment Account No.: 002-8810-2040, and

BE IT FURTHER,

RESOLVED, that the Town Board further authorizes the Town Budget Officer to transfer \$103,797.20 from Capital Reserve No.: 64 to Heavy Equipment Account No.: 002-8810-2040, amend the Town Budget and increase appropriations and revenues as follows:

- Revenue Acct No. – 002-0000-55031 (Interfund Revenue) - \$103,797.20;
- Expense Acct No. – 002-8810-2040 (Heavy Equipment) - \$103,797.20;
- Increase Appr 001-9901-9128-0064 Transfer to Operating Funds - \$103,797.20;

and

BE IT FURTHER,

RESOLVED, that the Town Board further authorizes the Finance Department to engage the auction company GovDeals to sell/dispose of the 2013 Ford Dump Truck (Town Asset No. 9016) and deposit any sales proceeds into the appropriate revenue account(s) in accordance with the Town Code and New York State Laws, and

RESOLVED, that the Town Board further authorizes the Town Supervisor, Cemetery Superintendent, Town Budget Officer and/or Finance Department to take any actions needed to effectuate this Resolution and payment to Robert Green Truck Division, and
